SUMMARY FROM THE DIRECTOR

Thank you for your continued partnership with the Turkey River Recreational Corridor. 2015 has been an exciting year full of successful projects, fun events, and active partnerships.

Major 2015 Accomplishments:

- Assisted the Fayette County Conservation Board in their receipt of a \$750,000 State Recreational Trails Grant for a total of \$1,086,000 raised for the TRRC trail extension from Elgin to the Gilbertson Conservation & Education Area
- Facilitated an electronic billboard featuring TRRC activities for 4 months (May-August 2015) outside of LaCrosse, WI
- Developed the Clermont StoryWalk Program
- Aired a TRRC Mediacom commercial featuring Fayette and Clayton County Conservation over a 6-month time period
- Held the TRI-P (Pedal, Paddle, Putt) on July 19th, 2015
- Coordinated the Turkey River Safari program (May-October 2015)
- Held the Turkey Trot 5K Race on October 17th, 2015
- Gained 112 followers on the TRRC Facebook Page and developed the TRRC Twitter account
- Conducted trail counts in the Summer (June/July 2015) and Fall (September/October 2015)

Grants/funds the TRRC received in FY 2015 (June 2014-July 2015):

- Iowa Tourism Grant (Digital Billboard Advertising) \$1,600.00
- Fayette County Community Foundation (Digital Billboard Advertising) \$2,365.30

Grants/funds secured for TRRC projects from partner agencies in FY 2015 (June 2014-July 2015):

- Fayette County Conservation: Regional Enhancement Trails Grant (TRRC Trail expansion from Elgin to Gilbertson Park) \$334,000.00
- Fayette County Conservation: State Recreational Trails Grant (TRRC Trail expansion from Elgin to Gilbertson Park) \$750,000.00
- Clayton County Conservation: Wellmark Foundation Community Kickstarter Grant (Trails for Clayton County!) \$10,000.00

\$5,875.00 was also raised from corridor businesses and private donors in January and February for Calendar Year 2015 TRRC projects and events.

A total of \$1,104,090.30 was raised for TRRC projects between June 2014 and July 2015.

As you read through the following report, take note that the Calendar Year 2015 runs within two fiscal years: Fiscal Year 2015 and Fiscal Year 2016.

Again, thank you for your continued support. The Turkey River Recreational Corridor Board and myself look forward to the exciting projects and events to come in the next year!

The digital billboard project was completed and featured outside of LaCrosse, Wisconsin. Multiple visitors cited the billboard as their reason for visiting the corridor.

Trees were planted along the TRRC trail between Clermont and Elgin with the help of Valley Elementary Students (see photo above).

The Clermont StoryWalk was installed in August outside of Clermont along the TRRC trail. It was moved in September in front of the Valley Elementary School near the Eagle's Nest. The StoryWalk was very popular and the Clermont Public Library would like to continue the project next year. There is also interest from the Elkader Public Library to install a StoryWalk in downtown Elkader.

All relevant grant reports were submitted.

Press releases were submitted throughout the year advertising various TRRC events, including the Turkey River Safari. These articles were featured in Fayette, Clayton, and Allamakee County Newspapers.

Mediacom aired a commercial featuring the TRRC and Fayette County & Clayton County Conservation over a 6-month period.

A TRRC advertisement was submitted to be featured in the Jan/Feb issue of Iowa Outdoors magazine (see right).

The Turkey River Safari was a success with 300+ participants in 2015. The TRRC Board would like to continue hosting the safari annually with new and re-visited sites every year.

\$5,875.00 was raised from corridor businesses and private donors in January and February for 2015 TRRC projects and events.

The following events were held in calendar year 2015:

TRI-P (Pedal, Paddle, Putt) on July 19th, 2015 Event Evaluation: The event was held on the rain date due to high river water levels. The TRRC Board has decided to change the event to a more traditional triathlon in calendar year 2016. This decision was based on participant feedback.

Turkey Trot 5k on October 17th, 2015 Event Evaluation: 19 participants ran in the event. The temperature was below freezing. Attendees had a good time and expressed interest in participating again next year.

Elkader Golf Challenge on September 20th, 2015 Event Evaluation: The event was held in conjunction with an existing event at the Elkader Golf & Country Club. The TRRC Board has decided to eliminate golf from future TRRC events for the time being due to low interest by recreational enthusiasts.








LARGE INFRASTRUCTURE GRANT WRITING This task shall require the NE IA RC&D to write up to one large infrastructure grant per year that will further the development of the Turkey River Recreational Corridor (TRRC) trail. \$1,000 will be budgeted annually for the NE IA RC&D to write one of the following grants per year (as needed): State Recreational Trails Grant, Federal Recreational Trails Grant, REAP grant, other.

Note: If grant is awarded, the TRRC will not be responsible for the balance of the RC&D fee. The applicant entity will be responsible for entering into a contract with NE IA RC&D and fulfilling obligations related to NE IA RC&D charges and fees associated with the grant writing contract.

The Fayette County Conservation Board's Project: "Turkey River Recreational Corridor-Elgin to Gilbertson Park" and the Turkey River received State Recreational Trails funding for \$750,000. This grant was written by Northeast Iowa RC&D staff, with assistance from the Fayette County Conservation Board. The grant writing fee for this grant was paid by Fayette County Conservation.

\$1,086,000 total is currently secured for the project to extend the trail across the Turkey River and into the Gilbertson Conservation & Education Area. It is the Fayette County Conservation Board's goal to raise an approximate \$52,000 more for the project.
